It comes pre-wired for connection to any ORP controller and has a modular design for easy assembly. The VersaChlor Easy Feed System II is extremely versatile and can be sized for commercial pools and commercial spas.

- VersaChlor E-Z Feed Systems and VC Tabs are available domestically through SCP, SPP and Lincoln Equipment
- The VC System II will be NSF / ANSI Std 50 Listed for use only with VersaChlor Tablets
- The VC System II is expected to be recommended for use with commercial pools up to 150,000 gallons (indoor) and for commercial spas with the separately sold tablet stacking canister


VersaChlor *Tablets*

VersaChlor calcium hypochlorite cubes are specially engineered and independently tested by the labs at NSF International to work in VersaChlor easy feed chlorinators in accordance with NSF/ANSI Standard 50. The tablets undergo a multi-step manufacturing and quality control process to ensure they will not soften, break apart or clog the system. VersaChlor cubes contain a scale inhibitor for clean chlorinator operation.

VersaChlor System II Specifications

Tablet Storage Capacity: 40 lb.

Electrical Requirements: 120 volt, 15 amp Power and 120 v ORP /CL2 Controller

The VersaChlor System II is designed to be used in conjunction with a Cl2 ORP controller

A 60 mesh in line strainer is provided for extra filtration on the pool water feed line to the chlorinator

The equipment warranty is 18 months from date of shipment to the branch

Operation of the VersaChlor System II

Inlet water supply line to the chlorinator and chlorine solution return line are 1.5". The inlet water supply is plumbed after the pool filter. The System II includes a 1.5 HP Hayward pump driving a venturi to pull chlorine solution out of the tablet hopper. Flow through the tablet hopper is manually controlled by adjusting a gate valve located on the inlet to the tablet hopper. The system is pre-wired to accept an on/off run signal from the pool controller ORP.
