

4. FIRST-AID MEASURES

<u>UNUSUAL FIRE AND EXPLOSION HAZARDS</u>: Run-off from fire control may cause pollution. Keep fire-exposed containers cool with water spray to prevent rupture due to excessive heat. High pressure water hose may spread product from broken containers increasing contamination. If involved in a fire, this product may decompose to produce a variety of compounds (i.e. carbon monoxide, carbon dioxide, and other compounds). 6. ACCIDENTAL RELEASE MEASURES

<u>SPILL AND LEAK RESPONSE</u>: Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. Proper protective equipment should be used. In case of a spill, clear the affected area, protect people, and respond with trained personnel.

The proper personal protective equipment for incidental releases (e.g.-1 L of the product released in a well-ventilated area) use impermeable gloves, specific for the material handled, goggles, face shield, and appropriate body protection. 7. HANDLING and STORAGE

WORK PRACTICES AND HYGIENE PRACTICES: As with all chemicals, avoid getting this product ON YOU or IN YOU. Wash hands after handling this product. Do not eat or drink while handling this material. Remove contaminated clothing immediately. Discard contaminated clothing items, or launder before re-use. Inform anyone handling such contaminated laundry of the hazards associated with this product. Use ventilation and other engineering controls to minimize potential exposure to this product.

<u>STORAGE AND HANDLING PRACTICES</u>: All employees who handle this material should be trained to handle it safely. Avoid breathing mists or sprays generated by this product. Use in a well-ventilated location. **Keep from freezing.**

For Non-Bulk Containers: Open containers slowly, on a stable surface. Containers of this product must be properly labeled. Store containers in a cool, dry location, away from direct sunlight, sources of intense heat, or where freezing is possible. Material should be stored in secondary containers, or in a diked area, as appropriate. Store containers away from incompatible chemicals. Keep container tightly closed when not in use. 10. STABILITY and REACTIVITY

STABILITY: Stable.

<u>DECOMPOSITION PRODUCTS</u>: Thermal decomposition products of this solution can include a variety of compounds. (i.e. carbon monoxide, carbon dioxide, and other compounds).

MATERIALS WITH WHICH SUBSTANCE IS INCOMPATIBLE: Gels and generates heat when mixed with acid. Absorbs carb on dioxide on exposure to air. May react with ammonium salts resulting in evolution of ammonia gas. Flammable hydrogen gas may be produced on contact with aluminum, tin, lead, and zinc.

11. TOXICALOGICAL INFORMATION

TOXICITY DATA: Additional toxicology information for components greater than 1 percent in concentration is provided below.

Acute Data: When tested for primary irritation potential a similar material caused moderate irritation to the eyes and slight irritation to the skin. Human experience confirms that irritation occurs when potassium silicates get on clothes at the collar, cuffs or other areas where abrasion may occur. The acute oral toxicity of this product has not been tested. When chemically similar sodium silicates were tested on a 100% solids basis, their single dose acute oral LD50 in rats ranged from 1500 mg/kg to 3200 mg/kg. The acute oral lethality resulted from nonspecific causes. This product contains approximately 30% potassium silicate. Other soluble lithium compounds have acute oral toxicity (LD50 values) in the range 500 mg/kg to 2100 mg/kg on a 100% basis. This product contains approximately 5% lithium silicate.

Subchronic Data: The subchronic toxicity of this material has not been tested. Repeated ingestion or ingestion of large doses of soluble lithium compounds is reported to cause temporary mental function impairment.

Special Studies: The mutagenic potential of this material has not been tested. Chemically similar sodium silicate was not mutagenic to the bacterium E. Coli when tested in a mutagenicity bioassay. Repeated ingestion or ingestion of large doses of soluble lithium compounds during pregnancy is reported to cause fetal abnormalities. Frequent ingestion over extended periods of time of gram quantities of silicates is associated with the formation kidney stones and other siliceous urinary calculi in humans. No ingredient of this product is listed by IARC, NTP or OSHA as a carcinogen.

CAS #: This is the Chemical Abstract Service Number which uniquely identifies each constituent. It is used for computer-related searching.

EXPOSURE LIMITS IN AIR:

ACGIH - American Conference of Governmental Industrial Hygienists, a professional association which establishes exposure limits.

TLV - Threshold Limit Value - an airborne concentration of a substance which represents conditions under which it is generally believed that nearly all workers may be repeatedly exposed without adverse effect. The duration must be considered, including the 8-hour Time Weighted Average (TWA), the 15-minute Short Term Exposure Limit, and the instantaneous Ceiling Level. Skin adsorption effects must also be considered.

OSHA - U.S. Occupational Safety and Health Administration.

PEL - Permissible Exposure Limit - This exposure value means exactly.

PEL - Permissible Exposure Limit - This exposure value means exactly the same as a TLV, except that it is enforceable by OSHA. The OSHA Permissible Exposure Limits are based in the 1989 PELs and the June, 1993 Air Contaminants Rule (<u>Federal Register</u>: 58: 35338-35351 and 58: 40191). BEI Biological Exposure Indices, represent the levels of determinants which are most likely to be observed in specimens collected from a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the TLV.
