4. First-aid measures

Inhalation Remove victim from contaminated atmosphere. If breathing is labored, administer oxygen. If breathing has

Keep people away from any upwind of spill/leak. Keep out of low areas. Keep unnecessary personnel away. Wear appropriate personal protective equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. Methods and materials for containment and cleaning up

Absorb in vermiculite, Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.
